Detective Maureen Sheehan, Shield 2195 of the Detective Borough Manhattan Special Victims Squad, states as follows:

The defendant is charged with:

PL 263.05

Use of a Child in a Sexual Performance
(defendant #1: 3 counts)

On or about February 21, 2015 at about 2:00 A.M., inside [REDACTED] in the County and State of New York, The defendant, knowing the character and content thereof, employed, authorized and induced a child less than seventeen years of age to engage in a sexual performance, and being a parent, legal guardian and custodian of such child, the defendant consented to the participation of such child in a sexual performance..

The factual basis for this charge is as follows:

I am informed by a person of an address known to the District Attorney's Office that on or about February 23, 2015, she observed three videos of her [REDACTED] posted on social media websites in which her [REDACTED] was having sexual contact with two adult males. I am informed that her [REDACTED] is thirteen years old.

I have viewed the three videos referenced above. On the first video, the child engages in oral sexual intercourse with the separately charged defendant Taquan Anderson, while the defendant, Daniel Hernandez, stands behind the child making a thrusting motion with his pelvis and smacking her on her buttocks. The child is nude in the video.

On the second video, the child is sitting on the lap of the defendant and the defendant has his arms around the child. The child is wearing a light colored bra and dark colored underwear and separately charged defendant Anderson pours a cup of liquid on the child's breasts and grabs the child's breasts with his hands.

In the third video, the child is completely nude and is sitting across the laps of the defendant and the separately charged defendant Taquan Anderson. The separately charged defendant touches the child across her legs and vagina with his hand. The same three individuals are observed in all three videos.

I am informed that the defendant's date of birth is May 8, 1996.

I further state that defendant Hernandez stated in substance to me: THAT IS ME
